WHAT DOES FIRST MERCHANTS BANK DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and transaction history
- Credit history and credit scores

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons First Merchants Bank chooses to share; and whether you can limit this sharing.

What First Merchants Bank Does With Your Personal Information From the Mobile Banking Application Why We Need Access to Your Information:

The Mobile Banking Application requests access to information stored on your device such as location, camera, contacts, or other features you are enrolled in to enrich and simplify the user's experience and improve services, as well as provide additional security to protect your account.

It is important for you to understand that:

- Before granting access to this information, you will be prompted to give the application that permission.
- If you do not wish to grant that permission, you may decline.
- If you later change your mind, those permissions can be updated in your device's settings.
- Alerts about important account activities and certain changes made to your Online Banking Account will be sent to the email address you provided for Online Banking. E-mail and secure messaging can also be used to send and receive messages from First Merchants Bank while in the Mobile Banking Application.

What We Need Access To And What We Collect And Share: Application Permissions are required to use specific features:

- Camera
 - Access to Camera Device to collect and share images for use of Remote Deposit Capture. We also share remote deposit information with a third-party check processor.
- Biometrics
 - Access for use of Identification
- Location
 - Access to Location Services for mapping
- Contact List
 - o Access to Contact List and Contact Images to collect and share for use of Zelle Contact Import

This application also stores the following data: Records of past payments and payments scheduled for the future.

How We Protect Your Information:

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

The application information is retained in accordance with state and federal record retention laws. Please contact us to determine specific timeframes for your personal stored information and if that information may be deleted.
